#### DETERMINE YOUR DOLLAR AMOUNT

The maximum amount you may contribute is the same as your state tax liability or the amount set by the state for your current tax year, whichever is less.

# 2023 Maximum Allowed Credits

\$2,609 for Married Filing Jointly Original: \$1,245 // Switcher: \$1,238

\$1,307 for Single/Married Filing Separately Original: \$623 // Switcher: \$620

#### 2024 Maximum Allowed Credits

\$2,910 for Married Filing Jointly Original: \$1,2308 // Switcher: \$1,301

\$1,459 for Single/Married Filing Separately Original: \$655 // Switcher: \$652
