DETERMINE YOUR DOLLAR AMOUNT

The maximum amount you may contribute is the same as your state tax liability or the amount set by the state for your current tax year, whichever is less.

 \$1,459 for Single/Married Filing Separately Original: \$731 // Switcher: \$728

2025 Maximum Allowed Credits \$3,062 for Married Filing Jointly Original: \$1,535 // Switcher: \$1,527 \$1,535 for Single/Married Filing Separately Original: \$769 // Switcher: \$766
